Final Words

I know this subject is controversial, yet we must find the courage to do our best to find out what really happened and who was responsible for what. It is simply not true that the story around what happened in Auschwitz can be regarded as "solved, case closed".

Over the years, quite a lot of documentation has become available which was secret at the time. Also, some investigations have been performed at the site, based on which results some experts say that it is simply impossible that the alleged gas chambers in Auschwitz could ever have been used for homicidal purposes.

And then there is David Cole, who made an excellent documentary on site, in which he manages to get the director of the Auschwitz museum to admit on tape that the gas chamber in Auschwitz shown to tourists is a post war "reconstruction":

We cannot ignore this kind of information just because the hard data contained within many documents which have become available in recent years does not fit the picture we have created together in our minds about what really happened.
