I was very surprised the ARD aired an interview with Frau Haverbeck and the fair podium she received for expressing her opinion on a rather controversial matter. The matter we are talking about from my point of view does not handle about racism and/or the spreading of hate, as is justifiable forbidden in The Netherlands where I live and which I agree with.

The matter we are talking about handles about the principal question of whether or not the Holocaust can be criticized and debated about in a civilized and professional manner, whereby we carefully consider the arguments pro- and contra and thus come to an informed opinion.

My personal opinion on the subject of what happened in Auschwitz specifically is based on information I researched and based on that information I have also come to the conclusion that it is highly unlikely that homicidal gas chambers were actually present let alone used at Auschwitz for murdering hundreds of thousands of people. The only gas chamber which I am aware of that actually existed and AFAIK is still there is located somewhere in the Elzas region IIRC. David Stein/Cole talked about it in an interview, if you're interested in finding out more about this.

Of course, I could be wrong in my analysis. It is always true that our opinion is based on the information we have. We simply cannot take information we are unaware of into consideration, which is why I refer to the information I used in order to come to my opinion.

My request to you is to take the information I refer to thoughtfully into consideration and come to an informed decision about whether or not Frau Haverbeck should be in jail for expression her opinion based on the information she had at her disposal and whether or not she crossed the line of reasonability in the way she expressed her opinion. It may be she should be accused of having been spreading hatred at some point, I don't know. To me, that is a question which is not mine to answer, because I don't have access to a sufficient amount of information in order to formulate an informed opinion on that matter.

In other words: I do not ask you to agree with me on the subject of what happened in Auschwitz. I ask you to carefully consider the information I referred to and formulate your own informed opinion on the matter, which may not necessarily agree with my opinion.
